Minutes of the Extraordinary Meeting of Moreton Say Parish Council held at The Clive Hall, Moreton Say on Thursday 24th January 2019 commencing at 7.30 pm

- 1. Welcome / Present / Apologises As listed above with Cllr Hughes chairing the meeting in the absence of Cllr Dutton.
- 2. Declarations of Interest None
- 3. Public Session There were 4 members of the public present one of which raised concerns about agenda item 4c in respect of the size of the building, the proximity to residential houses and the use of the building as they were concerned that there may be a change of use in the future. An issue was raised relating to the rubbish in the layby on the A41 south of Bletchley as the resident thought that there should be a rubbish bin in this area, the Clerk will take this forward. The potholes on the duel carriageway were also reported as opening up again and the Clerk will report this to Shropshire Highways.
- 4. Planning The following planning applications were considered and comments agreed:
 - a. 18/05523/REM Reserved matters pursuant to Outline Permission reference 15/03302/OUT dated 20th April 2016 for the erection of one dwelling and associated garaging to include appearance, landscaping, scale and design Proposed Dwelling SE of Longford Farm, Longford, Market Drayton, Shropshire Cllr Duffy proposed that this planning application be supported, Cllr Wellon seconded this and all agreed except Cllr Hughes who abstained.
 - **b.** 19/00205/FUL Creation of a new field access Shady Hollow Shrewsbury Road Market Drayton Shropshire TF9 3PR Cllr Turner proposed that this planning application be **supported**, Cllr Duffy seconded this and all agreed except Cllr Hughes who abstained.

It was unanimously agreed that no planning comments would be made in respect of this planning application but there were concerns raised by some of the members, relating to the on-going use of this building, which the Clerk was asked to raise with the Planning Officer.
